# MARINE CORPS RETIREMENT PLANNING GUIDE

### THE MONTH OF RETIREMENT

"This is it — the final month of your Marine Corps career. All of your preparation now comes together. Your mission is to execute the final outprocessing steps, secure your benefits, and step confidently into civilian life."

## Mission Critical Notice

At this stage, there's no room for missed details. Your focus is on **execution, verification, and closure**. Every checklist item must be completed before your EAS/retirement date.

# Phase 1: Final Outprocessing & Clearance

## **Outprocessing Execution**

- Attend final IPAC/S-1 out appointment
- Turn in completed **checkout sheet** with all required signatures (CIF, Finance, Legal, Medical, etc.)
- Pick up official **DD-214** review line by line for accuracy (name, SSN, awards, MOS, character of service)
- Obtain copies of retirement orders and clearance record
- Verify all **leave forms (DA 31/PTDY)** are processed correctly

#### **Identification & Access**

- Pick up Retiree ID card through DEERS/RAPIDS
- Ensure CAC is deactivated and removed from local systems
- Download or save any final files from .mil accounts before access ends

#### Phase 2: Benefits Activation

### Pay & Finance

- Confirm retirement pay account with DFAS
- Track first retirement pay deposit (usually 30–45 days after EAS)
- File final **travel voucher** (terminal/PTDY leave reimbursement) through Smart Voucher or unit finance
- Update MyPay with personal email and contact information

#### Healthcare & Insurance

• Confirm TRICARE enrollment via Tricare.mil

- Enroll in **FEDVIP dental/vision** at BENEFEDS.com (within 60 days)
- Enroll in VGLI through VA.gov (within 120 days if keeping life insurance)

#### **VA** Benefits

- Track VA Disability Claim status on VA.gov or eBenefits
- Respond promptly to any C&P exam requests
- Upload supplemental documents if requested
- Save claim confirmation number and keep personal records

# Phase 3: Family & Transition Support

#### Household & Relocation

- Confirm Household Goods (HHG) shipment is scheduled through DPS.move.mil
- Inspect quarters or housing for clearance (if in base housing)
- Coordinate move-in or lodging at new location

### **Family Readiness**

- Conduct final family transition meeting
- Review updated **family budget** with retirement pay and VA benefits
- Ensure spouse employment or education plans are on track
- Enroll children in new schools if relocating

## Success Metrics & Progress Tracking

- DD-214 picked up and verified
- Retiree ID card issued
- DFAS retirement pay account active
- TRICARE and FEDVIP coverage confirmed
- VA claim filed and status tracked
- HHG shipment scheduled and quarters cleared
- Family transition plans executed

### Common Pitfalls to Avoid

### **X** Mistakes

- 1. Not reviewing DD-214 thoroughly mistakes cause lifelong problems
- 2. Forgetting to update MyPay with personal contact info
- 3. Missing FEDVIP or VGLI enrollment deadlines
- 4. Assuming retirement pay will start immediately
- 5. Neglecting family relocation or spouse employment needs

## ✓ Success Strategies

- 1. Triple-check all documents before signing
- 2. Keep digital and physical copies of everything
- 3. Maintain close communication with DFAS and VA
- 4. Treat your final out as a mission no missed steps
- 5. Celebrate with family; they've been part of this journey too
