## United States Secretary of Veterans Affairs. The

Honorable Douglas A. Collins was sworn in as the 12th secretary of Veterans Affairs on Feb. 5, 2025, following his nomination by President Donald J. Trump. A native of Gainesville, Georgia, Mr. Collins saw public service modeled by his father, a Georgia State Trooper, and mother, who provided care to local senior citizens. He earned a degree in political science and criminal justice from the University of North Georgia. Secretary Collins earned his master's degree in divinity from New Orleans Baptist Theological Seminary, and his community roots deepened in the eleven years he pastored Chicopee Baptist Church. In 2006, the people of Georgia's 27th State House District elected Mr. Collins to represent them. During his first term in the state legislature, Collins graduated from Atlanta's John Marshall Law School and established his own legal practice.

As a U.S. Air Force Reserve chaplain, Mr. Collins has ministered to our country's military since 2002. He completed a 2008-2009 deployment to Iraq while stationed at Balad Air Base. He remains a colonel in the Air Force Reserve.

Secretary Collins served as a U.S. Representative for Georgia's Ninth Congressional District from 2013-2021. While he is a public servant, attorney, and practicing military chaplain, he remains foremost a husband to Lisa and

father to daughter Jordan and sons Copelan and Cameron. Lisa was a lifelong educator in Georgia's public schools, and together she and Doug are actively involved at Lakewood Baptist Church.




Acting Under Secretary for Memorial Affairs. Ronald E. Walters was named Principal Deputy Under Secretary for Memorial Affairs (PDUSMA) for the National Cemetery Administration (NCA), effective June 2009. From June 2014 through December 2017, and from January to June 2021, he led NCA in roles as interim and acting Under Secretary for Memorial Affairs. Prior to his position as PDUSMA, he served as NCA's Deputy Under Secretary for Finance and Planning and Chief Financial Officer from July 2006.

Mr. Walters helps lead 156 national cemeteries in providing dignified burial services for military Veterans and eligible family members. His responsibilities include: maintaining cemeteries as national shrines; land acquisition, design, construction, and other activities relating to the establishment of new national cemeteries; overseeing memorial programs to honor the service of deceased Veterans, including the provision of headstones, markers, medallions and Presidential Memorial Certificates; and administering federal grants to help states, territories and tribal governments establish Veterans cemeteries.

He was instrumental in efforts to modernize the approach to memorializing Veterans by establishing the Veterans Legacy Program and Veterans Legacy Memorial.

Mr. Walters represents NCA at congressional hearings, in briefings with members of Congress and their staff, Veterans Service Organizations, the Office of Management and Budget, advisory committees, and other interested groups. In his previous position, he was responsible for the successful implementation of key legislative mandates to include the Chief Financial Officers Act and the Government Performance and Results Act within NCA.



## 2025 Navy & Marine Corps Retiree Council

The Secretary of the Navy established the Navy & Marine Corps Retiree Council to consider issues of significant importance to retired military personnel and their family members, to facilitate interaction between Department of Navy leadership and the Navy and Marine Corps retired community, and to facilitate participation in other aspects of the Retired Activities Program.

The Council may review the effectiveness of current programs and policies affecting retirees and may make recommendations concerning improvements to privileges, benefits, assistance to retirees, quality of life, and any other matters relating to retired


#### The Navy's New Amphibious Transport Dock Ship will honor a Fallen Marine

The Navy officially named three future ships this past week, as well as the official name for its new class of ocean surveillance ships. The vessels honor two Navy veterans and underwater explorers, as well as a Marine killed in action during the Iraq War. Former Secretary of the Navy Carlos Del Toro announced the names at different events on 10 January. The amphibious transport dock ship LPD 33 will be named for 1st Lieutenant Travis Manion, an academy graduate who served in the Marine Corps with 1st Reconnaissance Battalion and fought in Iraq. On April 29, 2007, Manion and his fellow Marines were ambushed while searching a suspected insurgent house in Iraq's Anbar province. As he led a counterattack, Manion was fatally wounded by a sniper while aiding his wounded teammates. He deliberately exposed himself to heavy enemy fire to draw fire away from his wounded Marines. For his actions, he received the Silver Star and the Bronze Star with Valor posthumously. "Today, as our men and women continue to serve on the front lines, I know Travis would want this ship to be a tribute to this entire generation of veterans and a reminder to honor and remember their service and sacrifice," said Marine Col. (Ret.) Thomas Manion, chairman emeritus of the Travis Manion Foundation.

The San Antonio-class amphibious ship represents the combined power of the Navy and Marine Corps team and relies on the seamless integration of Sailors and Marines working together. Amphibious transport dock ships are warships that embark, transport and land elements of a landing force for a variety of expeditionary warfare missions. LPDs are used to transport and land Marines, their equipment, and supplies by embarked Landing Craft Air Cushion (LCAC) or conventional landing craft and amphibious assault vehicles (AAV) augmented by helicopters or vertical take-off and landing aircraft (MV 22). These ships support amphibious assault, special operations, or expeditionary warfare missions and serve as secondary aviation platforms for amphibious operations.

**Military Retiree and SBP Annuitants: Need a 1099 R?** Jump online, not inline to get your 1099R. You can have a 1099R mailed to you y ordering through our convenient online askDFAS request form. https://corpweb1.dfas.mil/askDFAS/ticketInput.action? subCategoryID=9725.

The IRS Form 1099-R is the retired pay and Survivor Benefit Plan (SBP) annuitant tax statement, like the W-2 provided to wage earners. The 1099-R documents the amount of your taxable retired or SBP annuity income and how much was withheld in taxes.

Retirees and SBP Annuitants: Managing Your Pay Account Just Got Easier! Managing your retired or SBP annuity pay account is easier when you use our new, more convenient askD-FAS online tools! # <u>DFAS - What to Do When a Military Retiree Dies?</u> What You Need to Know.

We are sorry for your loss, and we are here to help you. Although it's a difficult time, it's important to report the death of a military retiree promptly. Please use one of the options below to report the death of a retiree.

Information about claiming a retiree's final pay and claiming Survivor Benefit Plan payments (if the retiree was enrolled) is also included in this checklist.

Additional information is available on the DFAS Report a Retiree's Death webpage: https://www.dfas.mil/retdeath

Please note: The Arrears of Pay (AOP) beneficiary and Survivor Benefit Plan (SBP) beneficiary are designated by the retiree. They can be the same, but are not always the same. Separate claims must be made for AOP and SBP.

**How to Report a Retiree's Death.** Prompt reporting of a death is important to avoid overpayment. Retired pay ends on the date of death of the retiree. You can report a retiree's death using our online form or by calling our Customer Care Center, or via fax or mail. Filling out the online askDFAS Notification of Death form is the quickest and most convenient option. It's available 24/7.

**Supporting Documents Required.** We are required to have a copy of the retiree's Certificate of Death that states the cause or manner of death prior to making payments. If you have not yet provided this specific type of death certificate, please include a copy of it with your documents. ☐ The supporting documents to claim SBP depends on your individual situation. Please check our webpage for specific information: https://www.dfas.mil/startsbp

**Reminders.** Is your form signed and dated by you (and by witnesses for the AOP SF 1174)? ☐ Did you include supporting documents? Is the retiree's name and Social Security Number on each document?

# TRICARE Online Patient Portal Decommissioning: Download Your Health Records Now



On April 1, the TRICARE Online Patient Portal will no longer be available. The Department of Defense's new electronic health record.—MHS GEN-ESIS—has replaced the TOL Patient Portal. As part of the transition, the DOD is decommissioning the TOL Patient Portal. If you want to keep a copy of your legacy health records for personal use, you must download

them from the TOL Patient Portal before April 1.



"All military hospitals and clinics have transitioned to MHS GENESIS. We encourage you to take these important steps to save your personal health records before the TOL Patient Portal decommissions," said Rear Adm. Tracy Farrill, Principal Deputy, Assistant Director for Health Care Administration, and Military Health System EHR Functional Champion at the Defense Health Agency. "Your medical history is a valuable resource

for managing your health, and saving your records now ensures you have access if you need it."

## Why is the TOL Patient Portal decommissioning?

The MHS GENESIS Patient Portal has replaced the TOL Patient Portal. As detailed in the TRICARE Choices in the United States Handbook, MHS GENESIS allows you to access your EHR 24/7. You can also book and cancel appointments, request prescription refills and renewals, see clinical notes and certain test results, and exchange secure messages with your military healthcare team. The change from TOL to MHS GENESIS eliminates the need to maintain two systems and streamlines EHR management.

What Will Happen to My Records? Provider access: Your provider will continue to have access to your complete health records. Personal access: You can use the steps below to download your legacy records for personal use before April 1. You can also request a physical copy from your military hospital or clinic's records management office. To do this, you'll need to complete a request form in person, and then return at a later designated time to pick up the records. Beginning April 1, if you want your legacy health records, you'll have to follow this process.

What should I do now? To keep copies of your legacy health records, follow these instructions:

- 1. Visit www.TRICAREOnline.com
- 2. Log in: Sign in using your DS Logon, CAC, or DFAS myPay credentials. If you don't have a DS Logon, you'll need to create one by clicking "Need An Account."
- 3. Access: On the TOL homepage, click the blue "Health Record" button to view your personal health data.
  - 4. Find data: Select "Download My Data." You'll see several data categories.

- 5. Customize: Choose the person, data types, date range, and format for the records you want to download.
- 6. Download: You can choose to download your records in portable document format (.pdf) or as a (.xml) continuity of care document. The CCD format allows you to share your data with family, caregivers, providers, and healthcare systems, or to document data in your preferred personal health record.
- 7. Save: After downloading, you can either open the file or save it securely for future use. You can also print your records and store them in a safe place.

## Important details.

- \* Your records won't transfer to MHS GENESIS once TOL decommissions.
- \* Your TOL health records only reflect periods of time when your military hospital or clinic was using TOL. Note: If you moved from one duty station to another, and one military hospital or clinic used TOL and the other used MHS GENESIS, your records in MHS GENESIS may have gaps. You'll find these "gap" records in the TOL Patient Portal. Be sure to download them.
- \* You can only download your records from the past 30 years, from the date you log in to TOL.
- Protect your health information. When you download or print your personal health information, it becomes your responsibility to keep it safe. Use secure options. Avoid saving personal data on unsecure devices or platforms.

It's also important to know that if you're planning to file a claim with the Department of Veterans Affairs, this decommissioning won't affect your ability to do so. Providers will still have access to your complete health records.

## Can I see my children's health records?

Yes. You can view all available health data for your children under the age of 12. For children aged 12 to 17, you may view COVID-19, coronavirus, and flu test results, as well as allergies, vitals, and immunization data.

Due to state privacy laws, there are limits to what health data you can view online for your children aged 12 to 17. You can request printed results from your child's clinic or provider

#### Don't wait—take action

Remember: The TOL Patient Portal will only be available until April 1. Take the time now to download and store your health records to ensure you can easily access them if needed.

## Next Generation Uniformed Services ID Card



The Department of Defense transitioned from its legacy paper-based Uniformed Services Identification (USID) card to a more secure, next generation USID card. The Next Generation USID card incorporates an updated design and security features to deter counterfeiting and fraud, and is printed on a plastic cardstock. Initial issuance of the Next Generation USID card began on July 31, 2020 at select DoD ID card facilities, with phased implementation at all DoD ID card facilities, and completed in December 2020. USID cards are issued to retired and reserve members, dependent family members of uniformed Service members, and other eligible individuals in accordance with DoD policy to facilitate access to benefits, privileges, and DoD bases. The Next Generation USID card does not change the populations who are eligible to receive the current card.

Legacy USID cards remain valid through their expiration date, however, individuals with an indefinite (INDEF) expiration date on their legacy USID card may replace those ID cards with a Next Generation USID card.

## **Military Funeral Honors (TAPS)**

The Defense Department provides military funeral honors to recognize the sacrifice and contributions of our nation's veterans. The following individuals are eligible to receive military funeral honors: Military members who die while on active duty, Veterans who served in the active military, naval or air service, and were discharged or released from that service by means of an "honorable" or "under honorable conditions" discharge. Providing military funeral honors is the nation's way of showing gratitude and paying final tribute to a veteran's honorable military service.



Veterans may be eligible for one more year of G.I. Bill benefits. Are you a Veteran who served at least two periods of service? In other words, did you reenlist? If so, there's a chance that you're eligible for additional G.I. Bill benefits. Specifically, under the previous policy, eligible Veterans who served at least two periods of service were forced to choose between the Montgomery GI Bill and the Post-9/11 GI Bill for a maximum of 36 months of G.I. Bill benefits. Under the updated policy, Veterans will no longer have to make that choice when they apply for benefits, meaning that they can qualify for up to 48 months of G.I. Bill benefits. Am I eligible for allowances to help pay for a Veteran's burial and funeral

**costs?** You may be eligible for Veterans burial allowances if you're paying for the burial and funeral costs and you won't be reimbursed by any other organization, like another government agency or the Veteran's employer. You must also meet all of these requirements.

One of these relationships or professional roles describes your connection to the Veteran:

You're the Veteran's surviving spouse, or You're the surviving partner from a legal union (a relationship made formal in a document issued by the state recognizing the union), or You're a surviving child of the Veteran, or You're a parent of the Veteran, or You're the executor or administrator of the Veteran's estate (someone who officially represents the Veteran), or You're a family member or friend who isn't the executor of the Veteran's estate, or You're a representative from a funeral home, cemetery, or other organization.

# The Veteran must not have received a dishonorable discharge, and one of these circumstances must be true. The

Veteran died as a result of a service-connected disability (a disability related to service), or the Veteran died while getting VA care, either at a VA facility or at a facility contracted by VA, or The Veteran died while traveling with proper authorization, and at VA's expense, either to or from a facility for an examination, or to receive treatment or care, or the Veteran died with an original or reopened claim for VA compensation or pension pending at the time of death, and they would've been entitled to benefits before the time of death, or The Veteran died while receiving a VA pension or compensation, or the Veteran died while eligible for compensation or a VA pension at their time of death, but instead received full military

retirement or disability pay or The Veteran had been getting a VA pension or compensation when they died, or the Veteran had chosen to get military retired pay instead of compensation

Note: We'll also provide an allowance for the cost of transporting a Veteran's remains for burial in a national cemetery.

# You can't get burial allowances for certain individuals

We don't provide burial allowances if the individual died in any of these ways: On active duty, or While serving as a member of Congress, or While serving a federal prison sentence.


